Tribal-ISAC 2024 Annual Report Introduction

The Tribal-ISAC is the security information sharing platform and community for tribes and tribal enterprises across the United States. Founded under Tribal Share as a 501c3 non-profit and operated as a volunteer organization since 2021, the significant volunteer accomplishments are representative of the desire of the organization's growing membership to achieve the group's important purpose and mission. Tribal-ISAC Members believe that better preparedness and security is achievable by working closely together in a trusted relationship.

Overall, 2024 was another successful year that saw moderate growth in membership, awareness campaigns, and secured staffing by the Tribal Share and Tribal-ISAC teams and community. From a financial and funding perspective, 2024 was a year of sustained achievement for the Tribal-ISAC with small income boosts from new memberships. Currently, the organization is financially stable and sustainable on its own, but has yet to achieve the growth, reach and access to additional funding sources that can help the organization reach its larger goals.

This year we have added an advocacy component to our work. Our efforts to navigate standardization and reporting requirements have been instrumental in safeguarding sovereignty. Our work alongside over 70 tribes has never been more vital. Our collective voice has been crucial in ensuring that sovereignty is reflected in regulations and standards. We have amplified the reach of tribal voices amongst government and industry through public and private consultations with our members. We have also enhanced the meaningful participation of our members in policy and funding dialogues by connecting them with legal counsel and industry representatives. Our collective action has fostered accountability of related sectors and improved the advocacy posture of tribal entities. As we look ahead, we are confident that as we continue to grow in partnerships and services that we will strengthen the cybersecurity posture of Indian Country together.

At the start of 2024, the Tribal-ISAC Steering Committee listed three primary goals to enhance support of the important mission and purpose of Tribal-ISAC in better preparing and securing all Native American tribes and their enterprises. The goals were interdependent upon each other, and are listed below along with a short summary on the success level in achieving them.

Summary of 2024 Tribal-ISAC Priorities and Goals

1. Continue to increase revenue/funding and grow membership

- a. Increased Revenue: While we reached 96.40% of our total revenue budget in 2024, increasing revenue is a critical goal that remains in place each year and is perhaps the most important goal to allow us to achieve our overall mission. In 2024 we increased total revenue by approximately \$39,000 over 2023. Page 10 highlights financial details. The two main revenue sources that contributed to the increase in 2024 include: membership sales with a \$22,000 increase and the charity golf outing with a \$12,000 increase over 2023. The Tribal-ISAC ended 2024 with approximately \$131,000 cash in the bank. In 2024 a reserve fund in the form of a money market account was established in effort to gain interest higher than a checking account can yield. This fund fluctuates and holds any cash up to \$100,000 that is not required for monthly expenses. Tribal-ISAC will be looking to add new membership services from cash and added revenue in 2025 for the second consecutive year. A dependable Tribal-ISAC contract employee was secured in 2024, which should produce more positive results in obtaining and locating opportunities for new funding.
- b. Membership growth: We continue to grow membership. Page 13 highlights membership details. The active roster of cybersecurity professionals increased from 176 professionals at the end of 2023 to 295 as of 12/31/2024. Membership accounts also increase from 48. At the end of 2023 to 83 as of 12/31/24.

2. Add new membership service(s) using both existing cash on hand and 2024 revenue

a. Summary: We surpassed revenue expectations in 2024 and have planned ambitious goals for 2025 that will expand membership services now that a support position has been filled more consistently to coordinate volunteers and track initiatives. There is interest in providing talent development opportunities to the membership and producing a Tribal Report. Initiatives will balance leadership and technical offerings based opportunities to engage the members.

3. Produce tangible deliverables from all Tribal-ISAC working groups/committees

- a. Summary: The 4 Working Groups are meeting regularly as of the last quarter of 2024. They have produced infographics to express each group's mission, achievements, cadence, and plans for 2025.
- b. The welcome group i) launched monthly meet & greet meetings, ii) developed an onboarding presentation, provided administrative contact information, and iv) shared dates and the cadence of events.
- c. The repository group has i) obtained premium and nonprofit accounts, ii) drafted a file structure, iii) provided administrative access, and iv) recruited management assistance.
- d. The leading practice group i) restructured the focus of the legal working group to include policies and procedures. ii) added additional subject matter resources to the group, and iii) established a cadence for collaboration.
- e. The standards group i) expressed tribal concerns about standardization to GLI, ii) engaged with CISA about the effects of CIRCIA on tribes, and iii) assumed an advisory role in standardization.
- f. We also had steering committee members attend the MS-ISAC Annual Meeting, TribalNet, IGA, G2E, CISA's Tribal Consultation about CIRCIA, THSAC, and NCI throughout the year on Tribal-ISAC's behalf.

Tribal Share Board

The Tribal-Share board met twice in 2024- Q1 and Q4. General overview of priorities, goals, financials, approved budget and status/progress updates on core initiatives. All materials, logistics and coordination of the meeting were handled by the TribalHub team, led by Tribal Share Board Chair, Mike Day, and Tribal Share Board Treasurer/Secretary, Shannon Bouschor.

There were no changes in board members in 2024 or anticipated changes moving into 2025.


Tribal Share Financials

As was stated in the Annual Report introduction, 2024 was a year of sustained achievement for the Tribal-ISAC with an income boost from new memberships and the charity golf outing. Currently, the organization is financially stable and sustainable on its own, but has yet to achieve the growth, reach and access to additional funding sources that can help the organization reach its larger goals. Year-end review with the Tribal Share Board and Tribal-ISAC Steering Committee will determine how to expand member services or achieve other Tribal-ISAC goals with revenues that exceed expenses.

Tribal-ISAC Membership

By the Numbers

Membership saw a 67.61% roster increase of 119 cybersecurity professionals on the membership roster from 2023 (176 professionals) to December 2024 (295 professionals). The majority of our membership is from the following tribal verticals (in order):

- Gaming
- Gaming & Government (one IT division overseeing both)
- Government
- Health

2024 saw the addition of our first tribal gaming commissioners and law enforcement accounts. There was also an increase in non-gaming accounts.





Image generated from 2024 membership roster statistics

There are 15 Individual Memberships, 36 group Membership rosters, and 32 all-in Membership rosters. In some cases there are multiple tribal verticals sharing 1 tribal-wide Membership roster.



Group memberships allow up to 4 members and are the most common requested membership type. The most common upgrade type in 2024 is from an existing Group Membership upgraded to an All-in Membership. In 2024 we are continuing to see a recognizable uptick in existing TribalHub Members looking to upgrade their Membership to include a Tribal-ISAC Membership and started to see new members request Tribal-ISAC membership first. This appears to be a direct result of increased marketing of Tribal-ISAC to existing TribalHub Members, outreach at TribalHub events, and maintained connectivity with industry and federal agencies. Placement of Tribal-ISAC marketing materials and active direct sales of Tribal-ISAC membership at 7 regional events was influential in both exposure and in new membership in 2024.

2024 Membership Sales Overview

Membership experienced moderate growth in 2024 due to concerted and strategic efforts and resources dedicated to multiple channel marketing and sales outreach. The collaborative Tribal-ISAC session at the nationwide 2024 TribalNet Conference and Tradeshow offered cybersecurity minded conference attendees an immersive experience where they could interact with their peers on the issues tribes face in cybersecurity while collaboratively discussing potential solutions as a group with their industry peers. Expected 2024 Membership sales goals set by Tribal-ISAC leadership of \$125,000.00 were met and exceeded by \$2,600.00 for a total of \$127,600.00 including new memberships and renewals. January was the slowest month, at \$6,000. The strongest cash revenue months for membership were April and July at \$16,000 each. The September 2024 TribalNet Conference helped to yield a strong Q4 that exceeded sales goals for the year.

Member Engagement 2024

10% of members are engaged in leadership positions (i.e. Board, Steering Committee, and Working Groups) within the Tribal-ISAC and over 15% are engaged in planning supporting events with our partner TribalHub. Further, the Tribal-ISAC community discussion board had 118 active members engaging with and sharing information in 2024 including 4,700 page views, which is a 55% increase in active members and 172% increase in page views from 2023.

The Tribal-ISAC hosted 11 meetings in 2024. No meeting was held in September to accommodate travel to TribalNet, TribalHub's nationwide technology focused conference and tradeshow. Engagement was visibly increased in 2024 with more members participating and interacting in monthly meetings. Meeting attendance has grown to an average of 81 participants per meeting from 48. Vulnerability Management

Meetings with GLI and BakerHostetler about standards and CIRCIA respectively were timely additions to the meeting agendas that allowed members to learn how their tribe may be affected and how to respond. Roundtable discussions and Steering Committee Member updates allow the

members to share their own experiences, learn from each other, and hear about the Tribal-ISAC's work to advocate on their behalf.

2024 Tribal-ISAC Membership Marketing and Growth Strategies

The value proposition of Tribal-ISAC Membership continued to resonate in 2024 for those who would receive the most impactful and immediate improvements from engaging in a cybersecurity-focused community based on information sharing into their overall cybersecurity structure.

The three most effective new membership value propositions in 2024 were:

- Members who want the data of the The Daily Dispatch and cyber analyst reports, to attend
 Tribal-ISAC Member Meetings, and obtain resources from TribalHub.
- 2. Members who want strictly the cybersecurity shared data and do not desire further engagement with meetings.
- 3. Members who want to support the cause and passively attend meetings with topics that interest them the most.

Marketing campaigns maintained a public view of a nonprofit Tribal-ISAC that was clearly independent of their industry partner TribalHub, and acting entirely independently as well. Primary forms of outreach included 1:1 outreach, peer to peer, leads driven by Steering Committee, and email campaigns targeted to both IT and Non-IT titles by TribalHub to their database. LinkedIn campaigns are also planned for 2025 to promote membership with followers, as well as secondary and tertiary staff contacts and add targeted messaging for Data Privacy Week. We will start 2025 by delivering a year-end recap campaign of 2024 to all Tribal-ISAC Members to bring greater awareness to the accomplishments and value of the Tribal-ISAC.

Gate-15 Research/Analyst Report

Gate-15 is a contracted research/analyst and resource that provides ongoing support to the continued maturing of the Tribal-ISAC. Curated threat intelligence focused on the primary verticals of tribes (i.e. government, health, gaming & hospitality, and other enterprises) is their mission and primary deliverable. Specifically, Gate 15 provides a senior risk analyst and team to support the Tribal-ISAC by providing:

- Threat Analysis (IT and OT)
- Cyber Threat Intelligence
- Incident Response
- Malware Analysis (IT)
- Daily Highlights (Daily Dispatch delivered to all members each business day)
- Security Awareness/Education
- Ad-hoc Emerging Threat Advisories
- Threat Briefings/Webinars
- Monthly Threat Reports (3 each month)
- NATIVE Report (North American Tribal Incidents, Vulnerabilities & Exploits) qty 12/yr
- CHIEF (Cyber Hygiene Information, Education & Fundamentals) qty 12/yr
- Security Awareness PassItOn!- qty 12/yr

Cybersecurity and Infrastructure Security Agency (CISA)

CISA proposed the Cyber Incident Reporting for Critical Infrastructure Act (CIRCIA) on April 4, 2024. If enacted, this could require reporting all cyber incidents affecting tribes to the Federal Government. Tribal–ISAC responded in writing on July 3, 2024, emphasizing that this rule could negatively impact tribal governments and income–generating enterprises through referral for debarment or suspension from Federal programs in the event of non–compliance. We urged CISA to consult with all tribes and consider exemptions for sovereign nations to minimize these impacts.

As of October 14, 2024, tribal consultations with the Federal Government were made available. Kimi Gordy from BakerHostetler attended the November Membership Meeting to answer questions about the consultations. Steering Committee Member Lee Edberg spoke on behalf of the Tribal–ISAC to reiterate our members' concerns during one of the two consultation calls. Tribal–ISAC engaged BakerHostetler for legal advice and guidance to draft a CIRCIA response on behalf of Tribal–ISAC members. The response was submitted in writing on December 16, 2024 to reiterate our points. We emailed both of our response letters, the initial set of publicly available responses sent to CISA by tribes, the call for consultations, and a template response to the call for consultation directly to our members.

National Council of ISAC's (NCI)

This is our second year of membership in the NCI, a coordinating body designed to maximize information flow across and among key private and non-federal critical infrastructures and with the federal government. We now have consistent staff representation at NCI meetings and attended our first in person meeting and distributed an informational document to NCI partners explaining the value-added and complementary nature of Tribal-ISAC.

Tribal Homeland Security Council (THSAC)

Lee Edberg, Tribal-ISAC Steering Committee Member, and Renita DiStefano, Tribal Share Board Member, represented the Tribal-ISAC on this Advisory Council. The council has been assigned three topics:

- Cybersecurity
- Grant funding
- Missing people

The council met in Washington, DC on December 10th 2024. The Council recommended that federal agencies work together, become more integrated, clarify communication channels, provide education, and respect sovereignty. Tribal-ISAC was recommended as a conduit for engaging tribes regarding cybersecurity including associated grants.

Reflecting on his THSAC service, Lee stated "Our work is not done, and there are many more opportunities ahead of us, but I can share that the Tribal-ISAC is known and well respected amongst the federal agencies and other ISAC's. Our voice matters and our collaboration is appreciated, which was expressed to me by Mr. Rodney Lockett, former CISA Director, newly acquired DHS Director." In 2025, the new, incoming U.S. President and administration may continue with this Council or could move in a different direction.

Sponsorships

A sponsorship packet update was approved in January 2024 with Visionary, Giving, Golf, and general donation levels. We also produced a sponsorship card for distribution at 2024 TribalHub events. Further, Tribal–ISAC sponsorship opportunities were discussed at the 2024 TribalNet nationwide conference and tradeshow vendors meeting. There remains opportunity for growth in sponsorships and potential to drive this revenue stream in the future to include Giving Sponsors and increase general donations. LinkedIn and email campaigns are planned for 2025 to promote Visionary and Giving Sponsorships with followers, secondary and tertiary staff contacts, past sponsors, and TribalHub event vendors. The total sponsorships in 2024 were lower than anticipated or projected with the exception of the Golf Outing.

Third Annual Charity Golf Outing

The Annual Tribal Share Golf Outing is one of the primary funding sources for Tribal Share.

TribalHub is the contracted company to host, coordinate, manage and operate the golf outing in conjunction with their annual nationwide TribalNet conference and tradeshow.

The 3rd Annual Tribal Share Golf Outing was held at the Arroyo Golf Club in Las Vegas, NV the Sunday before the TribalNet Conference. All participants and funds support the efforts of the Tribal-ISAC.

In 2024 there was an increase in participation from both players and sponsors. An anticipated increase in expenses was experienced due to location while revenue remained similar to the previous year (-3.9% change in net revenue).


By the Numbers:

The golf outing is not only one the largest revenue streams for Tribal Share, it brings awareness to the Tribal-ISAC efforts and mission. Plans for a second charity golf tournament, the 1st Annual Par-Tee Fore Cybersecurity Golf Outing, are in the works for Miami, FL on February 25, 2025 at the Miccosukee Golf & Country Club - the Tuesday before TribalHub's 5th Cybersecurity Summit. We look forward to increasing participation not only with players but also sponsors, and are planning for another donation to AISES during TribalNet 2025 as well.

Industry Participation/Networking and Events

TribalHub Cybersecurity Summit - TribalNet Annual Conference - MS-ISAC event

2024 marks a year where Tribal-ISAC continues to gain traction as a trusted and familiar name among Indian Country. Attending consultation calls, webinars, and other events, there is a noticeable uptick in seeing and hearing others speaking about Tribal-ISAC rather than just our own group or our partner TribalHub doing so. This is a big accomplishment. Having representation at industry events is part of the strategy to continue that trend. In 2024, Tribal Share Board members, Tribal-ISAC Steering Committee members and general membership attended several events throughout the year like Indian Gaming Association (IGA), G2E, and others while informally promoting Tribal-ISAC. Plans to host a workshop in conjunction with an industry event are in the works for 2025. Details of three notable 2024 events with purpose and intention are included below.

TribaHub Cybersecurity Summit

Participation as a sponsor for the 2024 TribalHub Cybersecurity Summit gave the Tribal-ISAC a good amount of promotion along with the opportunity to host a booth at the virtual event. Tribal-ISAC leadership also hosted a panel session titled *Get Better Connected to Your Tribal Resources*. External marketing from TribalHub for this event was executed. In addition, Tribal-ISAC used LinkedIn to promote the sponsorship, sent emails to encourage attendance to current ISAC members and used the attendee list as a sales lead tool. The virtual booth also included information about the Tribal-ISAC including the most updated information packet, member benefits list, justification letter and more.

TribalNet Annual Conference

At the 25th Annual TribalNet Conference & Tradeshow, TribalHub gave the Tribal-ISAC a no cost sponsorship wherein Tribal-ISAC was promoted as the sponsor of the Cybersecurity Track.

Tribal-ISAC hosted an informational exhibit across from Tribal-Hub in 2024 to share membership and sponsorship opportunities with vendors and attendees. This included pre-promotion in event emails and signage during the TribalNet event as well as a VIP area for members during the first two days of TribalNet. In addition, Tribal-ISAC hosted a "Speed Solution Session". This session was led by the Tribal-ISAC Steering Committee members. The immersive session gave attendees an experience of what it's like to be a Tribal-ISAC member. This session was open to those employed by tribal governments, gaming enterprises or health facilities. Over 70 participants attended, and over 20 participants became prospective members. During the Speed Solution Session, outreach

cards were distributed to those who may want to learn more about Tribal-ISAC membership. These leads were collected and followed up on post conference. Similar sessions occurred at the two TribalHub regional events following TribalNet and are planned for all TribalHub's regionals and the Cybersecurity Summit in 2025.

MS-ISAC Annual Conference

During the 2024 MS-ISAC Annual Conference in Orlando, Tribal-ISAC coordinated the travel for Tribal Share Chair, Mike Day, to attend the event and show our collaboration with the organization. In addition, we organized dinner for any tribe who was in attendance with approximately 10 attendees. Posts were made to the Tribal-ISAC LinkedIN page during the event.

Administrative Services

Tribal-ISAC relies on volunteer services as well as paid services from Gate-15 and both paid and complimentary services from TribalHub. - Processing Sponsorships & Donations
- Producing Annual Report- gathering information required to present to the Tribal Share
 Board and Tribal-ISAC Steering Committee

2025 - Projections & Priorities

The Tribal-ISAC is proud of its accomplishments since its formation in 2021, but the Steering Committee and entire membership remain united and focused on growth and expanding the capabilities and reach of the Tribal-ISAC community in 2025.

In January of 2025 the Tribal Share Board and Tribal-ISAC Steering Committee will be presented with the budget on page 30 for approval.

A goal of Tribal-ISAC as a 501c-3 is not to hold cash in excess of the reserve fund, looking instead at ways to grow services to members. **Goals for 2025 include:**

- 1. Produce the first annual nationwide tribal cybersecurity report
- 2. Provide new talent development opportunities (e.g. scholarships / mentorships)
- 3. Provide tribes direct assistance with Cybersecurity grant writing and management
- 4. Continue to increase revenue/funding and grow membership
- 5. Establish Working Group operational improvements to increase productivity and deliverables
